COMMONALITIES

- HLP proved as an effective method for enhancing capacities, identify & scaling-up of good practices
- Promoting Good Governance and Decentralization with value of learning and replicating good practices
- Importance of cross-cultural sharing
- Mass participation with clear value systems (accountability, people centred governance, collaborative work with State and Non-state actors).

DIFFERENCES

- Each country has specific requirements and important initiatives
- Cross-cultural relevance of field initiatives will need for time and deliberation
- Replication/adaptation of country specific initiatives

WAY FORWARD

- Formal HLP Network among the countries/organizations
- Annual HLP Convention (Face to Face or Virtual), interested country/organization will arrange.
- Preparation of HLP training module to provide training to the interested candidate will participate.
- Mutual exchange of experts among the member countries.

DECISIONS OF THE FIRST HLP CONVENTION

- 1. HLP Foundation Bangladesh is requested to be the secretariat and coordinator of the convention.
- 2. Focal points to be nominated from each member.
- 3. To prepare the process of joining the new members in two months.
- 4. Members are requested to share the reports/activities with HLP foundation to be posted in website quarterly.
- 5. Next Convention: Date and place.
